AM Session: **11- 12, 13 – 14, 15- 19 swimmers**. The warm-up schedule will be posted on the league website after the entries are done. Meet starts TBA. **Fly Over Starts will be in effect**

PM Session: **7 – 8, 9 – 10**. The warm-up schedule will be posted on the league website after the entries are done. Meet starts TBA.

FACILITIES: Sussex Academy Aquatic Center 21150 Airport Road Georgetown, DE 19947

Facility:

The indoor pool has an 8-lane 25-yard pool with non-turbulent lane lines. We have starting blocks with a diving depth of 6 feet, Colorado timing system, locker rooms with showers, **only coaches, officials/ timers, swimmers and SCST Angels are permitted on the deck**. Passes will be provided to those allowed.

Everyone else must sit or stand in designated areas.

- Coaches may use the bleachers on the far side of the pool.
- Spectator seating will be on one designated bleacher on deck, it is our policy that all spectators use the restroom facilities located at the “Nest” which is the building next to the turf fields behind the Aquatic Center, locker rooms are for swimmers ONLY. No food can be eaten on deck.

Visitor Seating: The first row of our parking lot will be shut down to vehicles. Each team will be given space to set up and tents and chairs are encouraged. We ask that tents be put up in the parking spaces leaving the actual lane clear for emergency vehicles. Limited Handicap parking will be available please find a parking attendant for available options.

- Swimmers and siblings must stay with a parent when not swimming. If children are found running around the grounds unsupervised, their parents may be asked to leave the building by the on-duty police officer.
- Marshals: There will be about 8 marshals assigned to the meet and the board has assigned one Police officer to make sure the meet runs in an orderly fashion.

Normal Directions: **Please note Airport Road between Sussex Academy and Route 9 is closed.**

The Detour Route is the take US9 to South King Street to Airport Road.

- From the North: Follow Route 113 south to Georgetown, drive past Wal-Mart on the right and turn left at the traffic light at Royal Farms (Rt. 181 Bridgeville Rd) and continue onto N. Bedford St. Approximately 213 mile turn right onto the traffic circle, take the 3... exit onto E. Market St. Follow this road (Rt. 9) for one mile and the school will be on the right. Turn right onto Airport Rd. Turn right at the 1" entrance and go straight to the rear parking lot. The pool is in the rear of the building. Do Not Park in the area designated for Officials, please!
- From the South: Follow Route 113 north to Georgetown, turn right at the traffic light (Rt.9) at the M&T Bank. Approximately 213 mile turn right onto the traffic circle, take the 2011 exit onto E. Market St. Continue on this road (Rt. 9) for one mile and the school will be on the right. Turn right onto Airport Rd. Turn right at the 1" entrance and go straight to the rear parking lot. The pool is in the rear of the building. Do Not Park in the area designated for Officials, please!

Photography: photography from **behind the blocks** is PROHIBITED and FLASH photography at the start is PROHIBITED. Only credentialed commercial photographers will be permitted on deck.

Parking: See the facility and parking map at the end of this document.

Swimmer Area: Swimmers will be staged outside in the parking lot with their teams.

Vending: There will be a full snack bar provided all day. There will be a vendor on site selling various swim items. There will be a meet program available for purchase as well as a meet t-shirt and towel.

Clerk of Course: The initial clerk of course will at the door adjacent to the Aquatic Center and by the School's Gymnasium. Swimmers will enter the pool area located behind the blocks. **All swimmers regardless of age must report to the clerk of course.**

RULES: Current 2021 DSA rules apply using 2021 USA Swimming stroke and turn rules.

ELIGIBILITY: All swimmers age 6 to 19 entered must have competed in at least two (2) dual, triangular or sanctioned Invitational meets this season and swam equal or faster than the cut times to compete in Championships. These meets must have been included on the official schedule or have been make-up sessions in which both teams were originally scheduled to participate.

Entries and Fees:

- **All entries must be submitted by Saturday at 7 pm July 24, 2021** to the entries director Allan Nelson at

ankmm2323@comcast.net. We need your entries to do warmup, timer assignments and prelim psych sheets.

- Additional qualifiers from a Sunday Invitational may be added by 7 p.m. **Sunday July 25, 2021**. (Just send an updated entry file)
- Entries must be submitted using the 2018 Championship Events for Team Manager file from the web, it is set up to convert all best times to yards.
- **Please check to be sure the entry times since box is set up to only use times that were achieved on or after 6/20/2021**
- Entries submitted on paper will not be entered in the meet.
- **Individual events are \$6.00. Relays cost \$15.00.**
- **There is a \$5.00 facility fee per each individual swimmer.**
- **Coaches, please check the web on Sunday evening for the psych sheet.** Every year a swimmer is left off and no one ever checked the psych, or it was not caught until the day before the meet.
- **Payment options: Please Use PayPal!!!!** You can send a check, but it must arrive by the Tuesday deadline
- **DO NOT USE YOUR ENTRY PROGRAM ie TM or UNIFY, for your entry fees total due, USE the meet fees report by team that will be posted on the Champs page Sunday night at 8 PM. USE THIS AMOUNT ONLY! John can then match dues with teams when it arrives in our PayPal account.**
 1. A single check payable to "DSA" must be received by the league treasurer by Tuesday July 27, 2021 (John 16672 Woodland Court Bridgeville, DE,19933). All packages sent that require a delivery signature must complete the 'Waiver of Signature.'
 2. To pay via PayPal go to your PayPal account and click on send money to "Friends and Family" button. Next type in the DSA email address in the pay to box DSASWIM@GMAIL.COM and enter the amount of your meet fees from the team meet fees report. Click on next to verify the account you are paying from bank or credit card and TYPE IN YOUR TEAM NAME IN THE NOTES BOX so we can identify what team is sending the money to mark you PAID. Payment must be received by the league treasurer by Tuesday July 27, 2021
- **Individual Entries:** All swimmers must swim in their own age group for all individual events based on the May 31 age up date.
- **Relays:** Every DSA team is entitled to one "A" relay team per age group. There is no Cut Time for relays so any swimmer can participate but swimmers must still meet the two meet qualifying rule even if they did not make a qualifying time for individuals at champs. Alternate relay swimmers must be designated on your entries and must not exceed the total number of entries rule.
- **Relay Swim-up:** Any swimmer may be upgraded one (1) age group for relays as long as they do not exceed the maximum entries rule.
- **Maximum Entries:** The max entries is the same as the summer dual meets: A max of 5 events -- swimmers are limited to a maximum of three (3) individual scoring events and two (2) relays
- **Penalties:**

Any team that has not paid its League Dues, fines, Championship entry fees, or has outstanding sanctioned Invitational fees for the current year shall not participate in the League Championships. Swimmers, even if they are seeded in Champs, will not swim if any outstanding fees are unpaid.

Rosters: All coaches are to send a roster of their team's swimmers to the league Webmaster. **Rosters must have been submitted by July 1, 2021.** Teams not submitting full rosters by July 1 will be subject to a \$25.00 fine, due and payable as a condition for entries being accepted for this Championship Meet. Any additions to the roster should have been sent

later in the season but not later than this meet entry due date. All swimmers must be bona fide members of the team they represent.

NEW Dual meet Results: In addition, one electronic PDF copy of your seasons results covering of ALL meet results must be emailed to the league secretary, Kelly Gardner as part of the entries deadline Saturday July 24, 2021 or entries will not be imported.

Next Year's Race Requests: Teams must make their 2022 meet selections via the web page "Race Pics Online" or directly to Frank Raines FRisTCB@aol.com on July 15, 2021 in order to be entered in the Championship meet. Go to <http://www.delmarvaswim.org> then Race Pics Online.

SCORING: There are three divisions: Blue, Red and White. Teams are assigned divisions based on the previous years overall team scores. Teams in each division will score points against teams within their division only, using the points system listed below. Divisions are posted on the Champs tab of the web page.

Scoring for Individual Events: 16, 13, 12, 11, 10, 9, 7, 5, 4, 3, 2, 1

Scoring for Relays: 32, 26, 24, 22, 20, 18, 14, 10, 8, 6, 4, 2

AWARDS: Each of the three divisions will receive awards as follows: ages 6 - 18

- Medals 1st thru 3rd
- Ribbons 4th thru 8th
- Trophies for each high point age group by team for both boys and girls.
- The top three teams in each division will receive a plaque. \

Ages 19 will swim exhibition, will not score, or record or ribbon. Their time will be on the result sheets as EVENT age group 19

ALL AWARDS MUST BE PICKED UP AT THE CONCLUSION OF THE MEET, AWARDS LEFT WILL NOT BE MAILED AND WILL HAVE TO BE PICKED UP.

GORDON MAYNES AWARD - During the morning session between relays the Scholarships will be awarded, and the Gordon Maynes award will be given.

SENIOR BIOS - For our senior swimmers, their Biographies will be read during their one of their swims and in our program. All senior Biographies must be submitted to Allan Nelson <mailto:ankmm2323@comcast.net?subject=Senior Bio> at 6pm in order to be in the program.

SCHOLARSHIP Recipients – Winners will be announced During the AM session Breaks

RESULTS: Real time results will be available the day of the meet via mobile phone by getting the free app for droid based or iphone called "Meet Mobile". Meet Mobile is dependent on Wi-Fi availability. Meet Mobile does have an option to buy just one day of use. Meet results will be on the <http://www.delmarvaswim.org/> web site Sat pm.

QUALIFYING TIMES: All swimmers in individual events must have met the Championship qualifying times during that year's season at official League meets. This shall include any DSA approved Invitational, except that no "split" times shall be submitted. Times established in time trials or non-league meets shall not be submitted. There will be no unofficial swimmers.
